## TERENGGANU INC GROUP RECORDS REVENUE OF RM1.2B IN 2021

26 September - Terengganu Inc and its Group of companies recorded an increase in revenue for the financial year ended 31 December 2021 to RM1.2 billion, surpassing the previous year's performance of RM1.0 billion.

The President and Executive Director, YBhg Encik Burhanuddin Hilmi bin Mohamed @ Harun said the Group's revenue shows an increase of 14% or RM148.1 million against the financial year 2020, contributed by better performance within its subsidiaries.

Other notable trends include the Group's profit before tax and zakat which recorded an increase of 364% (RM60.9 million) to RM77.7 million from RM16.7 million in the financial year 2020.

The latest foodbank is located at Bukit Gasing National School, Marang ensures targeted assistance to the local community in need.

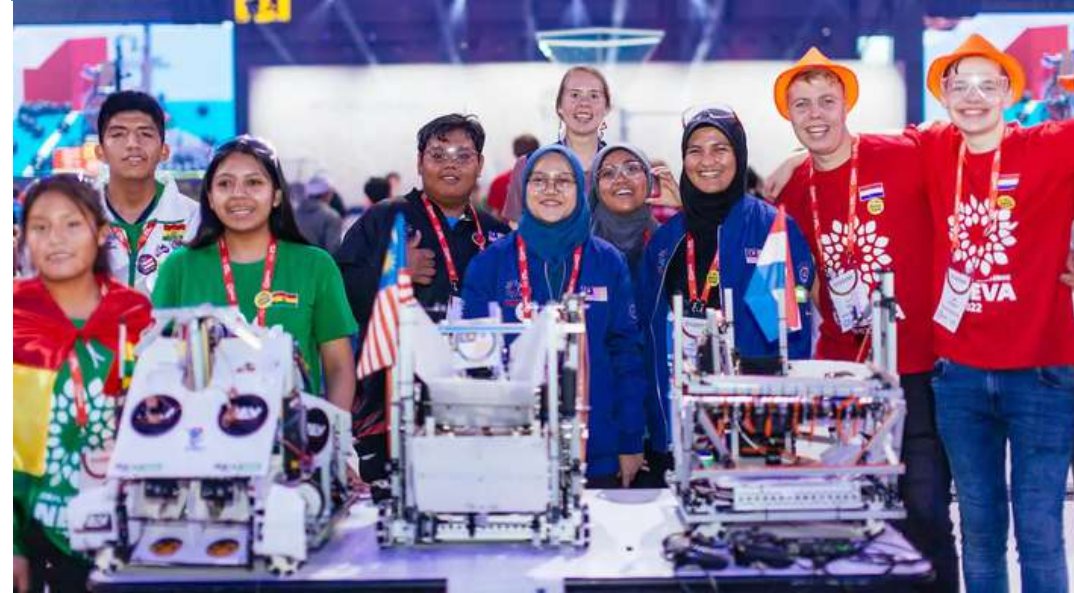


## TDMP CELEBRATES 1,500 WORKERS
