KMI HEALTHCARE EXPANDS TO SABAH

7 July - KMI Healthcare, a subsidiary of TDM, celebrated a significant milestone with the official launch of its 5th private hospital, KMI Tawau Medical Centre (KMI Tawau), in Tawau, Sabah.

The completion of the acquisition of Tawau Specialist Hospital in May 2022 marked a pivotal moment for KMI Healthcare. The hospital has since been rebranded as KMI Tawau Medical Centre.

Chairman of KMI Tawau, YB Dr Aliakbar Gulasan, presided over the event, which was attended by esteemed representatives from government agencies, corporate clients around Tawau, as well as senior management from both TDM Berhad and KMI Healthcare.

As part of their expansion plans, KMI Healthcare is also undertaking the development of a new 5-storey building, set to increase the bed capacity to 59, with a target completion date in Q4 2024. Notably, KMI had been effectively managing the hospital's operations since January 2018.



SATU'S BUKIT BERAPIT WTP ENSURES FRESH WATER FOR 160,000 USERS

4 July - Syarikat Air Terengganu Sdn Bhd (SATU) has successfully inaugurated the Bukit Berapit Water Treatment Plant (WTP) in Kuala Nerus which will be a solution to the problem of saltwater intrusion in the Terengganu River, meeting the needs of treated water for 160,000 current users.

The construction of this LRA started on 31 July 2017 with a capacity of 120 Million Liters per day (MLD), and is aimed at meeting the needs of the treated water supply of Kuala Terengganu, Kuala Nerus and part of Setiu district. The WTP also is able to meet the needs of up to 480,000 users in the future.

16 July – TDM is proud to announce that its fully owned subsidiary, Kumpulan Medic Iman Sdn. Bhd. (KMI Healthcare), has successfully launched the KMI Chukai Medical Centre Groundbreaking Ceremony, officiated by the Menteri Besar of Terengganu, YAB Dato' Seri Dr Ahmad Samsuri bin Mokhtar. This is the second specialist hospital to be developed in the state of Terengganu after KMI Kuala Terengganu Medical Centre.
